## **President's Message**

You've heard the phrase that the only two sure things in life are death and taxes. Well, tax season is upon us and--good news! The Federal filing deadline is moved to May 17th! The good news goes on--Illinois has also extended their deadline as well.

While we're still around, most of us will continue to need health care. Many retirees, in order to save money, choose to use TRICARE, If you're a user of Standard, which is now called Select, at zero cost, the landscape has changed. Unless you're on active duty, medically retired, or survivor of an active duty member who died on active duty, you need to enroll before the end of June 2021 and pay premiums back to January 1, 2021. Otherwise, the next opportunity is November 2021 or because of a Life Qualifying Event. Premiums are \$12.50 per month for individual and \$25 for families.

# 2021 USO and Fisher House Donations Drive

#### HONORING OUR BEST CONTRIBUTOR

For thirteen of the fourteen years our chapter has been collecting money and Wish List items for the USO of Missouri and later, starting in 2011, for St. Louis Fisher House, we have had one major consistent overly generous contributor. Every chapter member who has followed the year-after-year reporting of our chapter's success should know the name of this benevolent No guessing necessary, it is St. contributor. Michael's Episcopal Church of O'Fallon, Illinois.

This singular contributor, whether collecting money or Wish List items, has never failed to excel in their outstanding support of our chapter. Testimony to their responsiveness is evident in these facts with representative numbers:

- Including this year's anticipated final numbers, of the approximate \$56,000 combined the chapter will have handed over to the USO and Fisher House, about \$21,000 will have been contributed by St. Michael's. That's 38% of the total.
- To focus on collecting only money, St. Michael's stopped collecting Wish List items in 2016. Before that change, of the total of 13,700 pounds combined of Wish List items delivered

in the years up to 2016, 5,700 pounds were collected by St. Michael's. That's 42% of the total.

• This year is an amazing example of the church's continuous progress. Last year's record combined collects of \$2,470 was beaten this year by 22%, to a new record high of exactly \$3,000.

It is worth mentioning that about one third of the contributors at St. Michael's are also MOAA members. In effect, their contributions get credited twice – first to the credit of St. Michael's and then to the credit of the chapter. But that in any way should diminish the essence of the church's involvement. The same pattern pertains to any outside contributions, or, for that matter, to an individual giving who is a chapter member. It's just the mechanics of the collections process. Eventually, the chapter gets the full credit it deserves.

I think it's also worth observing the value of having an outside person or group contributing. With members cultivating outside contributors, the chapter's opportunity for even more successful campaigns becomes magnified, and each yearly endeavor at collections becomes a true campaign – not just members donating because the chapter has made a commitment. Just review the St. Michael's example above and envision what you might do.

you need to enroll before the end of June 2021. Otherwise, the next opportunity is November 2021 or because of a Life Qualifying Event. #### Watch for the opportunity to send a message to Congress in the coming months on the bills listed here.

- Federal HR 5995: A bill to amend title 10, United States Code, to expand eligibility to certain military retirees for concurrent receipt of veterans' disability compensation and retired pay or combat-related special compensation, and for other purposes.
- Federal HR 413: A bill to amend the Internal Revenue Code of 1986 to allow the work opportunity credit to small businesses which hire individuals who are members of the Ready Reserve or National Guard, and for other purposes.
- Federal HR 847: A bill to provide interim appropriations for the Coast Guard Retired Serviceman's Family Protection and Survivor Benefits Plans for each fiscal year after fiscal year 2018, and for other purposes.
- Federal S 3393: A bill to amend title 10, United States Code, to provide for concurrent receipt of veterans' disability compensation and retired pay for disability retirees with fewer than 20 years of service and a combat-related disability, and for other purposes.
- Federal S 21: A bill making continuing appropriations for Coast Guard pay in the event of an appropriations act expired prior to the enactment of new appropriations (official title to be confirmed).
- Federal S 1047: A bill to amend title 38, United States Code, to create a dependency and indemnity compensation allowance for surviving spouses receiving dependency and indemnity compensation from the Department of Veterans Affairs, and for other purposes.



#### **Legislative News (continued)**

- Federal S 2216: A bill to require the Secretary of Veterans Affairs to formally recognize caregivers of veterans, notify veterans and caregivers of clinical determinations relating to eligibility for caregiver programs, and temporarily extend benefits for veterans who are determined ineligible for the family caregiver program, and for other purposes.
- Federal S 2981: A bill to reauthorize and amend the National Oceanic and Atmospheric Administration Commissioned Officer Corps Act of 2002, and for other purposes.
- Federal HR 2406: A bill to amend the National Oceanic and Atmospheric Administration Commissioned Officer Corps Act of 2002 to make certain changes to the National Oceanic and Atmospheric Administration's commissioned officer corps, and for other purposes.
- Federal S 2629: A bill to amend the Public Health Service Act with respect to the Public Health Service Corps.
- Federal S 2297: A bill to authorize appropriations for the Coast Guard, and for other purposes.
- Federal HR 333: A bill to amend title 10, United States Code, to permit retired members of the Armed Forces who have a service-connected disability rated less than 50 percent to receive concurrent payment of both retired pay and veterans' disability compensation, to extend eligibility for concurrent receipt to chapter 61 disability retirees with less than 20 years of service, and for other purposes.

## Congress Pulls Plug on TRICARE Dental Program Transition to FEDVIP

The FY 2021 National Defense Authorization Act (NDAA) stops the planned transition of active duty and National Guard/Reserve families who use the TRICARE Dental Program (TDP) to the Federal Employees Dental and Vision Insurance Program (FEDVIP). MOAA supports this move and will continue working to ensure Congress and the Defense Health Agency (DHA) remain committed to addressing known problems with TDP networks.

TDP is a voluntary dental plan available for purchase by active duty family members, transitional survivors, and Guard and Reserve members and their families. A similar move did take effect

for the TRICARE Retiree Dental Program (TRDP): The FY 2017 NDAA sunsetted TRDP and made military retirees eligible for dental and vision coverage through FEDVIP as of Jan. 1, 2019. There are no changes to retiree dental and vision coverage – military retirees are still eligible for FEDVIP.

MOAA and other advocacy groups took this issue to Capitol Hill, and Congress responded by including language in the FY 2019 NDAA that would have made TDP beneficiaries eligible for FEDVIP effective Jan. 1, 2022. The FY 2021 NDAA reverses these plans. The TRICARE Dental Program will remain in place.

For most TDP beneficiaries, DoD pays 60% of the plan premium while the servicemember contributes 40%. Complications related to DoD's premium contribution, among other issues, hampered efforts to transition TDP to FEDVIP.

MOAA supports this move by Congress to ensure all TDP beneficiaries have continued access to affordable dental coverage, and we are encouraged by recent steps the DHA has taken to address issues with TDP.

# Advocacy in Action: Details on MOAA's Spring Campaign

The big event this year is Advocacy in Action, the new name for our annual legislative push on Capitol Hill.

Last year, due to the pandemic, we were forced to pivot our engagement to virtual platforms — this gave us an opportunity to include others in these meetings over the month of May. Not quite a bright silver lining, but it did give many others the opportunity to be part of our advocacy mission from home and helped generate over 19,000 letters spread out over every congressional office — all 535! Our members conducted 253 meetings in virtual platforms — on top of those letters and phone calls — to ensure 100% contact.

Based on too many unknowns this year, MOAA will repeat the virtual meetings, again targeting the month of May. Check your MOAA Newsletter and MOAA's Advocacy News page (at this <u>link</u>) for updates.

Topics this year address those who are currently serving, veterans and recent retirees, and members of the National Guard and Reserve forces.

#### **Topic 1: Comprehensive Toxic Exposure Reform**

This focus on comprehensive toxic exposure reform highlights those currently serving, veterans, those recently retired from active duty, and the Guard and Reserves. When most people hear about toxic exposure, they think of Agent Orange and Vietnam, and we work that, too. However, there is a significant lack of awareness of the current toxic exposures for those in uniform today and since 9/11.

Among one of the more notable and impactful exposures are from the burn pits and other fires during the Gulf War in Afghanistan and Iraq. Additionally, there are exposure risks from firefighting chemicals and contaminated drinking water, to name a few.

#### **Topic 2: TRICARE Young Adult Parity**

There is a glaring disparity between commercial health care plans that cover adult children to age 26 and TRICARE, which requires a separate premium for young adult coverage. In 2013, TYA monthly premiums were \$152 for Standard and \$176 for Prime; today, those monthly fees are \$257 and \$459 respectively, which is an unsustainable curve, charting a course for TYA plan failure.

The Health Care Fairness for Military Families Act of 2021 (H.R. 475), sponsored by Reps. Elaine Luria (D-Va.) and Michael Waltz (R-Fla.), expand TRICARE eligibility to young adult dependents up to age 26. Learn more about the legislation at this <u>link</u>.

#### **Topic 3: Basic Needs Allowance**

This proposed allowance would address our servicemembers and their families who are most vulnerable to food insecurity and are finding it difficult to make ends meet. The subsistence allowance would be provided automatically to servicemembers whose gross household income (not including their Basic Allowance for Housing, or BAH) is below 130% of the federal poverty line. This recurring struggle was exacerbated by COVID-19 layoffs.

While a small number of servicemembers qualify for the Supplemental Nutrition Assistance Program (SNAP), many do not because their BAH is considered income. These families turn to food pantries instead: The Armed Services YMCA reported a 400% increase in grocery demand at their food pantries on and near military installations during the pandemic.

# Senate Reintroduces Concurrent Receipt Legislation, With Strong Support (Link)

Nine days after Major Richard Star, USAR, lost his battle with cancer from toxic exposure, Sens. Jon Tester (D-Mont.) and Mike Crapo (R-Idaho) reintroduced the Major Richard Star Act (S. 344) with 42 Senators as original cosponsors.

The legislation will authorize concurrent receipt of DoD retired pay and VA disability for those injured in a combat zone and forced to medically retire under Chapter 61.

Senators are growing bipartisan support for this legislation – part of an incremental strategy to chip away at the larger concurrent receipt problem that has an associated \$33 billion price tag.

"When it comes to our nation's disabled veterans, we've got to cut through the bureaucratic red tape that's prevented them from getting the full benefits they've earned," Tester said. "The Major Richard Star Act would fix the unfair offset that prevents thousands of veterans living with the wounds of war from accessing both their disability benefits and retired pay. And it honors the service and sacrifice of Major Richard Star, whose legacy lives on in our continued fight to ensure our men and women in uniform get the assistance they deserve."

#### Where Is the Legislation in the House of Representatives?

The House is on a different schedule than the Senate and will also reintroduce the Major Richard Star Act very soon. Reps. Gus Bilirakis (R-Fla.) and Raul Ruiz (D-Calif.) will champion the Continued next page

legislation again this year in the House. Last year, the bill ended in the 116th Congress with support from 101 representatives. Increasing support for this legislation is critical for the bill to pass – either as a standalone measure or as part of the National Defense Authorization Act.

# MOAA Asks DoD to Implement Dependent Care Flexible Spending Accounts (Link)

MOAA has prioritized child care as a key military family issue for 2021 and is actively promoting recommended solutions to DoD and Congress. In our latest effort, MOAA partnered with the National Military Family Association to author a white paper to persuade DoD to implement Dependent Care Flexible Spending Accounts (DCFSAs). The Military Coalition, a group of advocacy organizations representing a combined 5.5 million members of the military community, sent a letter along with the white paper to senior leaders at DoD, asking them to consider the move as "one of many reforms" required to address child care issues.

#### What Are DCFSAs?

DCFSAs are a pre-tax reimbursable employer benefit program allowing an employee to designate up to \$5,000 per plan year out of their paycheck for child care or adult care expenses. These dollars can be used not only for traditional day care services, but for before- and after-school programs, babysitting, and nanny services. DoD has the statutory authority to implement this benefit, but decided against doing so after a 2007 implementation study, citing tax and usability concerns. The difficulty in finding and paying for child care has continued to increase in the 14 years since DoD last considered offering DCFSAs.

### **AAFES Will Offer Chiropractic Services at Select Locations (Link)**

The Army and Air Force Exchange Service, or AAFES, is opening more dental and medical equipment service centers on military installations in 2021. And in a first, it will also bring chiropractic services to selected locations in the U.S.

Currently, AAFES offers wellness services on several military locations worldwide, including:

- 139 optical and optometry clinics
- 17 durable medical equipment shops
- 9 dental offices

AAFES is planning to open seven additional durable medical equipment shops and eight dental offices at locations worldwide this year.

New to the exchange wellness program in 2021 will be six chiropractic clinics, slated to open at Fort Campbell, Kentucky; Fort Carson, Colorado; Fort Stewart, Georgia; Joint Base Lewis-McChord, Washington; MacDill Air Force Base, Florida; and Nellis Air Force Base, Nevada.

All exchange wellness locations accept Tricare and most private insurance programs.

"With exchange wellness offerings, service members and families can get what they need without having to go off the installation," said Air Force Chief Master Sgt. Kevin Osby, exchange senior enlisted adviser. "The exchange remains committed to making life better for military communities throughout 2021."

The services are available to all authorized exchange customers including active-duty members, retirees, family members and all disabled veterans.

# MOAA on the Hill: Testimony Outlines Legislative Priorities for Veterans (Excerpt, read full article at this Link)

MOAA is looking out for veterans' access to health care – a topic increasingly important as the COVID-19 pandemic continues to stifle daily life across the country.

Cory Titus, MOAA's director of government relations for veteran benefits and Guard/Reserve affairs, outlined the association's legislative priorities for the VA during a joint Veterans Affairs Committee virtual session on March 3rd. MOAA is advocating for examining the department's COVID-19 response, eliminating health disparities for women and minorities, and passing comprehensive toxic exposure reform, among other priorities.

Rep. Mark Takano (D-Calif.), chairman of the House Veterans Affairs Committee, said the hearing provides an opportunity for lawmakers to hear directly from veterans on their needs.

"This is one platform that allows us to her many voices," Takano said. "... it gives us the opportunity to discuss ways to build better veterans programs that can ... address problems for all veterans."

MOAA's priorities are focused on improving services in the Veterans Health Administration, which oversees the VA's health care facilities, and Veterans Benefits Administration, which includes a wide range of benefits, such as disability compensation and transition programs.
