Legislative News (continued)

Advocacy in Action is MOAA's annual one-on-one meetings with our Congressional representatives. This year's event will take place in April. Congress is in recess from April 11-22, so the time available to meet with the representatives will be short. As happened last year, the meetings will be virtual, and the team of Col (ret) Richard Smith and Col (ret) Bob Norman will meet with four Illinois representatives, including Mr Mike Bost of Illinois's 12th Congressional District, and Senator Dick Durbin. It is likely that Mr Bost will be the only member to take the meeting, while others will have a staff member attend the meeting. Three issues will be brought to the table:

- 1) The Major Richard Star Act (concurrent receipt for combat-injured servicemembers,
- 2) reduce TRICARE mental health copayments, and
- 3) enact a 4.6% military pay raise in the FY2023 National Defense Authorization Act (NDAA).

Major Breakthroughs on Toxic Exposure Reform from VA, Congress, White House

(Link) (Updated March 3 with House passage of Honoring Our PACT Act)

The push to provide veterans exposed to toxins during service with the benefits they deserve took significant steps forward on all fronts to begin the month, from the halls of Congress to the State of the Union address to a major change in VA policy.

MOAA has worked with both the legislative and executive branches for years to secure comprehensive toxic exposure reform, looking to avoid the mistakes and major delays from previous generations and create a transparent, rapid process for determining and rewarding benefits to veterans. The issue took center stage March 1 as part of the president's State of the Union address.

"The VA is pioneering new ways of linking toxic exposures to diseases, already helping more veterans get benefits," President Joe Biden said. "And tonight, I'm announcing we're expanding eligibility to veterans suffering from nine respiratory cancers. I'm also calling on Congress: Pass a law to make sure veterans devastated by toxic exposures in Iraq and Afghanistan finally get the benefits and comprehensive health care they deserve."

On March 3, the House of Representatives moved on the president's request, passed the Honoring Our PACT Act (H.R. 3967) 256-174. The omnibus reform bill moves to the Senate, which has passed less-comprehensive legislation.

Illinois Legislation


House Bill 5184, an amendment to the Military Veterans Assistance Act, seeks to clarify the county Veterans Assistance Commissions (VAC). The bill was submitted by Representative Stephanie Kifowit (D-84), chair, House Veterans Affairs Committee, and has been amended twice in the House. In checking the witness slips there were 55 slips submitted in opposition to the bill and only 9 in favor. In spite of the number opposing the legislation, on March 4, the bill was read for the third time in the House, and resulted in 104 yeas and none against. This with only 12 co-sponsors in the IL House. The bill passed to the IL Senate by Senator Charles Wilcox (R-32) and currently has 3 IL senators. Co-sponsoring including Sen Wilcox. The bill was referred to the Assignments Committee. No date has been established for a vote in the Senate as yet. However, when the Readings are scheduled to take place, Witness Slips supporting the legislation need to be submitted prior to the Reading and Debate.

As responsible Chapter members, two things need to happen:

- (1) download the witness slip instructions, and
- (2) post the witness slip in favor of Illinois HB5184.

Everyone in the Chapter should submit a witness slip in support of HB5184. There are currently 9 proponents and 55 opposed.

We need your support ASAP and before the next hearing which is yet to be scheduled. The Illinois General Assembly website for HB5184 is at this <u>link</u>.

Should You Contribute to a Flexible Spending Account? (Link)

Your civilian employer may offer you a host of benefits previously unavailable to you as a member of the military. The onboarding process can be overwhelming and confusing, and it's not always immediately clear which benefits make sense for your needs.

There are two you may want to consider, however, especially if you pay for child care and have even moderate out-of-pocket health care expenses: the health flexible spending account (FSA) and the dependent care FSA.

What Is an FSA?

Some employers offer a flexible spending account (also known as a flexible spending arrangement) funded by an employee's salary deferral that the employee can use to pay for certain out-of-pocket health care costs. Employers may also contribute to the account.

For 2022, the IRS limits health FSAs to \$2,850 per year per employer. If you are married, your spouse can put up to \$2,850 in an FSA with their employer as well. Note that employers may set lower limits for their workers. You can use FSA funds to pay for certain medical and dental expenses for you, your spouse, and your dependents. News from National MOAA

For more information about the articles in this month's newsletter and how you can get more involved in other issues, visit the MOAA <u>Take Action Center</u> or <u>News</u> webpages. Also, here are some of the active Legislative Campaigns MOAA is engaged in:

- Help Military Families Today (Link), ACT NOW to urge your senator to help military families by securing financial relief for the U.S. child care industry.
- Shutdown Update: USPHS, Coast Guard, NOAA Remain in Flux (Link), MOAA has advocated for full funding of the government to allow the Coast Guard, National Oceanic and Atmospheric Administration Commissioned Officer Corps, and U.S. Public Health Service Commissioned Corps to complete their mission and to allow their members to avoid financial hardship.
- Ask Your Senator to Back Bill That Improves Survivor Benefits (Link), Tester's bill, the Dependency and Indemnity Compensation Improvement Act, would increase the amount of DIC paid to surviving spouses and align the benefit with other federal programs. The proposal, which could net survivors an extra \$5,400 a year, has been a long-time goal of both MOAA and The Military Coalition.
- Advocacy in a Virtual Environment: How to Make Your Voice Heard (Link), MOAA's Government Relations team regularly meets with lawmakers and their staffs in remote settings to ensure that servicemembers past and present, their families, caregivers, and survivors remain a priority for the 117th Congress. There are many ways MOAA members can support these efforts by advocating from your home.:
 - **Call:** One of the easiest ways to engage with your lawmakers is to call, using MOAA's direct line to the Congressional switchboard at (866) 272-6622, and ask the Capitol operator to connect you with your legislator's office.
 - **Send a Letter:** Typically, a member of Congress prefers letters on legislative issues be sent to their Washington, D.C., office. Click these <u>House</u> and <u>Senate</u> links to find your elected officials' D.C. addresses.
- Ask Your Lawmaker to Preserve the Prestige of Our National Cemetery (Link), A recent Congressional Research Service (CRS) publication may add to the confusion some lawmakers face regarding the future of Arlington National Cemetery (ANC) yet another reason to make your voice heard at this critical stage.

News from National MOAA (cont) (Link)

- Military Treatment Facilities Adding QR Codes to Prescription Packaging (Link), Throughout 2022, military treatment facility (MTF) pharmacies will be replacing printed monographs or MedGuides (the paper medication guides that come with many prescription drugs) with QR codes on prescription packaging. Patients can request a paper copy if they prefer the printed version.
- 17 Medical Centers Would Close Under Proposed VA Realignment (Link), The Department of Veterans Affairs has unveiled a plan that calls for closing 17 aging or underused medical centers, while shifting services to more than 30 new or rebuilt hospitals. In some cases, it would rely on private care.
- What Does the VA Facility Realignment Plan Mean for Veterans' Health Care? (Link), The VA released a report March 14 outlining its plans to strengthen and modernize medical infrastructure to meet the changing needs of the veteran population.
