Since 1929, MOAA has been involved in several major legislative accomplishments that have secured significant gains for the military community, not because these were “good ideas,” but because our military and veteran members deserved the support for their sacrifice at many levels. Relying on the membership-at-large to make their voices heard by contacting lawmakers, MOAA's successes are

indeed noteworthy and sometimes astounding, as they collaborate with other like-minded organizations and The Military Coalition. Here are a few of the successes:

[Note: Items with an asterisk () are periodically under attack or under-resourced.]*

- Repealing SBP-DIC offset, known as the ‘Widows Tax’ – saving up to \$12,000 per year for nearly 67,000 surviving spouses.
- Executing a credible game plan for oversight of DoD’s health care – protecting continued access to quality care.*
- Securing comprehensive privatized military housing reform – improving housing, establishing Tenant Bill of Rights, and Congressional oversight.*
- Lessening impact of TRICARE fee hikes (Family = \$300 vice \$900) – fighting multiple efforts to end grandfathering for those who entered service before Jan. 1, 2018.*
- Protecting TRICARE For Life (TFL) – blocked five consecutive administration budgets proposing TFL enrollment fees (2013-2017).*
- Maintaining pay raise comparability – ensuring pay raises for our uniformed services keep pace with civilian sector increases.*
- Providing Wounded Warrior protections and caregiver enhancements – securing multiple improvements to VA caregiver programs.*
- Defeating ‘COLA Minus 1 Percent’ – ending Congressional attempts to reduce retired pay, costing an E-7 retiring after 20 years \$83,000, and an O-5 \$124,000, by age 62.*
- Securing major GI Bill upgrades to include transferability – and improving benefits for National Guard on Title 32 orders.*
- Boosting compensation significantly for retirees with 50% VA disability – still fighting for the rest to include those medically retired.*
- Improving Guard and Reserve TRICARE coverage – and securing a premium cut.
- Ensuring Guard and Reserve retirement age credit for active duty service – now allowing 90 days to stretch over two consecutive years.

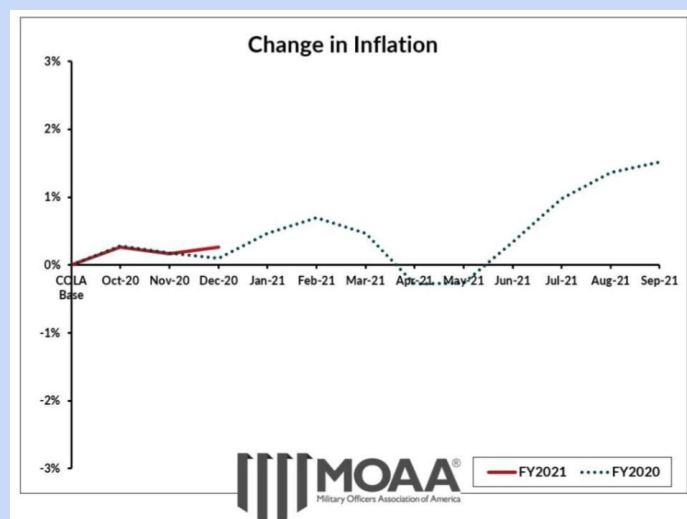

Also in the January 2021 issue of Military Officer Magazine, the Chairman of MOAA, General Walter “Skip” Sharp, USA (ret) provided the following goals for the Association in 2021:

- **Advocacy.** Centering on service-earned entitlements such as health care, pay, and benefits.
- **Expanding the scope of MOAA’s charities.** Scholarship Fund for deserving students, The MOAA Foundation to help military families, and the COVID-19 Relief Fund to provide emergency financial assistance for struggling servicemembers and veterans.
- **Increasing engagement and member experiences.** Building on MOAA’s success to attract and retain members with programs and services, and innovating influence through the magazine and digital products.
- **Increasing membership.** Getting the word out on who we are and how we advocate for servicemembers and veterans and their families.
- **Innovating chapters and councils.** Financial and training support to our state council presidents, and expanding the virtual chapter program.
- **Focusing on diversity.** Diversity of the board of directors to ensure proper representation.

For most of us who live near a Military Treatment Facility, getting immunizations may not be an issue of cost or payment. Shane Ostrom lays out guidance to consider for the medical payment coverage for the Shingles shot, one type which is recommended for anyone over 50 years old and another recommended for those over 60 years old. TRICARE covers the shingles vaccine two different ways – under your medical coverage, or under your pharmacy coverage. For those age 64 and under and not on TRICARE For Life (TFL), the full cost of the shot is covered by TRICARE Prime, US Family Health Plans and TRICARE Select plans, whether administered at a pharmacy or at a doctor’s office. TFL offers a bit more of a challenge. Of course, over 65 means Medicare, but the shot is covered by Part D Pharmacy coverage, which is generally not used by military retirees. So, because Medicare Part A or B does not cover the shot, the entire cost of the shot falls to TFL, which means two options: (1) use the TRICARE pharmacy benefit by going to a TRICARE network pharmacy and get the vaccine for free, or (2) get the shot at a doctor’s office, which falls under medical coverage and TFL deductibles and cost shares apply. Bottom line is that you pay for the shot. Consider your options and select wisely.

Federal - S 3393 -- A bill to amend title 10, United States Code, to provide for concurrent receipt of veterans' disability compensation and retired pay for disability retirees with fewer than 20 years of service and a combat-related disability, and for other purposes.

Federal - S 21 -- A bill making continuing appropriations for Coast Guard pay in the event of an appropriations act expired prior to the enactment of new appropriations (official title to be confirmed).

Federal - S 1047 -- A bill to amend title 38, United States Code, to create a dependency and indemnity compensation allowance for surviving spouses receiving dependency and indemnity compensation from the Department of Veterans Affairs, and for other purposes.

Federal - S 2216 -- A bill to require the Secretary of Veterans Affairs to formally recognize caregivers of veterans, notify veterans and caregivers of clinical determinations relating to eligibility for caregiver programs, and temporarily extend benefits for veterans who are determined ineligible for the family caregiver program, and for other purposes.

Federal - S 2981 -- A bill to reauthorize and amend the National Oceanic and Atmospheric Administration Commissioned Officer Corps Act of 2002, and for other purposes.

Federal - HR 2406 -- A bill to amend the National Oceanic and Atmospheric Administration Commissioned Officer Corps Act of 2002 to make certain changes to the National Oceanic and Atmospheric Administration's commissioned officer corps, and for other purposes.

Federal - HR 5995 -- A bill to amend title 10, United States Code, to expand eligibility to certain military retirees for concurrent receipt of veterans' disability compensation and retired pay or combat-related special compensation, and for other purposes.

NDAAs Include Free National Park Access for Gold Star Families

A provision of the 2021 National Defense Authorization Act (NDAA) will give Gold Star families free access to public lands across the country.

The "America the Beautiful National Parks and Federal Recreational Lands Pass" has an \$80 annual price tag for most Americans.

Now, Gold Star families, defined as those who lost a family member in war, an international terrorist attack, or a military operation outside of the United States, will also be eligible for the free admission pass.

The pass gives free access to the holder of the Gold Star Family pass as well as up to three passengers per vehicle 16 years and older. Children under 16 are admitted for free.

While active duty military members and their dependents have had free access to National Parks for several years, and disabled veterans qualify for the free Access Pass, there has been confusion about exactly who is and isn't eligible for the programs, with enforcement and rules sometimes varying by location.

But a wave of new legislation and park policy has clarified the program over the last several months. In November, Interior Department officials announced that the free pass program would extend to all veterans and Gold Star family members. Early this month the president signed into law a rule granting the pass to disabled veterans. And, once signed by President Donald Trump, the change included in the NDAA will move from park policy to law the free pass for Gold Star families.

While not all of our nation's 2,000 public recreation areas charge entrance fees, many of the more popular destinations such as Yellowstone National Park and Grand Canyon National Park charge an admission price of up to \$35 per vehicle.

Besides giving free admission to all National Parks, the pass also holders free admission to other participating Department of the Interior agencies as well as sites administered by the U.S. Forest Service and the U.S. Army Corps of Engineers.

The National Park Service has already begun issuing the free passes under their November policy change. Interested Gold Star families can download the application at:

The program does not cover expanded amenity fees such as camping, tours, special recreation permits or organized groups or concession-operated facilities or activities.

Many states also offer free access to public lands for military members, veterans and Gold Star families. In many cases you don't even need to be a state resident to get free access. See what your state offers at:
