
#### Update: House Overrides President's Veto of the FY2021 NDAA, 23 Dec 2020 (link)

The House of Representatives on Monday evening voted to override the President's veto of the FY2021 National Defense Authorization Act (NDAA). The Senate is expected to begin considering an override on Tuesday with a vote possible by Jan. 3, according to The Hill. President Donald Trump on Dec. 23 vetoed the NDAA, which previously cleared Congress with large bipartisan support. The bill includes several MOAA-backed provisions.

#### These MOAA-Supported Bills Will Improve Survivor Benefits (<u>link</u>)

Despite the repeal of the "widows tax" in last year's National Defense Authorization Act (NDAA), there is still work to be done for Congress to improve equity for survivor benefits. MOAA and The Military Coalition, a group of military and veterans service organizations representing a combined 5.5 million-plus membership, continue to advocate for the survivor community and seek legislation to address existing inequities. One such

piece of legislation making its way through both the House and Senate will do just that by lowering the so-called "remarriage penalty" and allowing more survivors of seriously disabled veterans to receive Dependency and Indemnity Compensation (DIC) benefits. Another would raise the DIC rate, and a third combines the two bills.

Back in November, over 100 Representatives and 46 Senators, along with over 30 veteran service organizations, implored members of the House and Senate Armed Services Committees to retain in the NDAA the addition of bladder cancer, hypothyroidism, and Parkinsonism to the list of conditions presumed to be connected to Agent Orange exposure for our Vietnam veterans. About 34,000 Vietnam veterans stand to gain from the legislation if passed. Based on all the backing, the language was included in the FY21 NDAA that passed the House on December 9. At the time of this writing, the bill had yet to clear the Senate, but looked favorable. The following is what to expect in the \$731.6 billion NDAA that authorizes everything from pay and benefits for servicemembers and families to the size of the force if the Senate accepts the House version. MOAA's recent efforts look to benefit servicemembers and their families, to include a 3% military pay raise, a halt to proposed military medical cuts and military treatment facility (MTF) reorganization, and the addition of three conditions to the list of ailments presumed connected to Agent Orange exposure.

- Military Pay Raise: 3% military pay raise, effective Jan. 1, 2021, matches the administration's request. In addition to a general pay increase, Congress increased Hazardous Duty Incentive Pay to \$275 per month for duty in a foreign area designated as an imminent danger area or high-risk duties.
- Toxic Exposures: Vietnam veterans benefit from language including three new presumptives on the list of illnesses linked to Agent Orange exposure: bladder cancer, hypothyroidism, Parkinsonism.
- Guard and Reserve: A House provision expanded hazardous duty incentive pay parity for the Guard and Reserve was adopted in the final bill. Reserve component personnel who maintain a proficiency will receive monthly pay like their active-duty counterparts receive when fulfilling required proficiencies like parachute duty, aircrew duty, and many others.
- Commissaries and Exchanges: Senate adopted House language that seeks an update the business case analysis (BCA) before moving forward with efforts to merge the back-office operations of the commissary and exchange systems. A GAO report identified flaws in cost and savings estimates in the initial Business Case Analysis (BCA), which will require a new BCA prior to DoD proceeding with plans for the consolidation. *Continued next page*

- Medical Billet Cuts and Military Treatment Facility (MTF) Restructuring: Language prohibits reducing medical end strength authorizations for 180 days following enactment of the bill, requires DoD to conduct a review of medical manpower requirements that specifically considers the homeland defense mission and DoD's role in a pandemic influenza response, in addition to all other national defense strategy scenarios. Another provision increases requirements for implementation plans for each MTF slated for restructure or realignment, and also requires DoD to certify to the congressional defense committees that a covered beneficiary affected by restructure or realignment of a MTF would have access to health care services through the purchased care component of the TRICARE program.
- TRICARE: No new TRICARE fees or copay increases. A new enrollment fee for TRICARE Select (formerly Standard) for Group A retirees (joined prior to January 1, 2018) will go into effect January 1, 2021 a change that became law with the FY17 NDAA. Benefits expanded under the TRICARE Extended Care Health Option (ECHO) which covers services for a subset of military special needs families with individuals who are diagnosed with intellectual disabilities, a serious physical disability, or an extraordinary physical or psychological condition, includes an increase in respite hours from 16 to 32 hours per month, and also requires a Government Accountability Office (GAO) report on caregiving assistance available under other programs, including Medicaid home- and community-based services.
- DoD Jobs & the 180-Day Rule: Allows direct hire of certain retired military members (GS-13 and below) in logistics positions that are facing manpower shortages, letting these qualified candidates bypass a rule requiring a 180-day waiting period.
- Spouse and Family Issues: Improvements to the Exceptional Family Member Program (EFMP) to ensure continuity of services and standardization across the services. Continuity of education for families with special needs will get a closer look by the GAO as well. The My Career Advancement Account (MyCAA) program will be expanded to include continuing education and national testing.
- Clarifications for the licensure reimbursement program to ensure military spouses moving from overseas to stateside can take advantage of the program. Child care improvements are expected to include housing prioritization for Family Child Care (FCC) providers, expansion of 24-hour child care, family discounts at child development centers, a pilot program to provide financial assistance to families utilizing FCC child care, and several reports addressing affordability and availability concerns. DoD also must conduct a feasibility study to implement dependent care flexible spending accounts.
- Military Housing: Improvements to military housing, including repeal of DoD's authority to lease out substandard housing, implementing recommendations outlined in the DoD Inspector General's report on housing, and language ensuring performance metrics and remediation guidance for housing issues are made public. Expands the Uniform Code of Basic Standards for housing along with inspection requirements to government-owned military family housing. An audit also will be conducted to track medical conditions of residents in privatized military housing. Finally, DoD now expected to take certain military family readiness issues into consideration when making future basing decisions.
- Cheryl Lankford Memorial Expansion Assistance: Improves assistance for Gold Star families by increasing support offered by Casualty Assistance Officers (CAO). Ia\f a Gold Star spouse dies, their dependents will receive the support of a CAO to advocate for the family, answer questions, log complaints, and assist with the benefits process.

### **Amazon Smile**

I stumbled onto something today that our members might be interested in. Probably all of us shop on Amazon - well, Amazon has a project by which they will donate to the charity of your choice (among their millions listed) based on how much you shop on Amazon. The project is called AMAZON SMILE.

If the item that you order has listed in the description area that it is eligible for AMAZON SMILE, then Amazon will donate 0.5% of the cost of that item to the charity that you selected. The shopper cannot claim a tax deduction on his/her tax return because it's Amazon who is shelling out the money to the charity. To date, Amazon has donated \$217M to US charities and \$237M worldwide. That's a lot of money.

And if you want, you can shop on the AMAZON SMILE website and actually donate needed items to that charity. Since you are paying for those items, you can get a tax deduction.

### What TRICARE For Life Enrollees Should Know About Medicare Advantage Plans

As a Medicare/TRICARE For Life (TFL) enrollee, you get to choose which type of Medicare you want: Original Medicare Parts A and B or Medicare Advantage Plans Parts A and B. Original is the federal government insurance. Advantage is a commercial insurance company. Both act as your major medical coverage. Medicare Advantage plans are all Medicare by law and are also known as Medicare Part C.

Medicare approves and contracts with insurance companies to offer Medicare Advantage plans. The Advantage plan becomes your Parts A and B Medicare coverage. Per Medicare law, the Advantage plans must be as good as — if not better than — the original Medicare Parts A and B.

Medicare Advantage plans work with TFL benefits — just like your Original Medicare Parts A and B. However, you can make coordination between TFL and an Advantage plan go more smoothly by calling TFL at (866) 773-0404.

The premium amount of the Advantage plans can vary, but many use your established Part B premium amount as their monthly premium cost. Your Part B premium will pay the insurance company rather than Medicare. Some plans' premiums can be more than the Part B premium for the extra benefits provided. Advantage plans can provide extra insurance in the form of dental, vision, hearing, or health and wellness coverage. Some Advantage plans may have other costs beyond the premium like deductibles and copays, and some could cost less.

You must comparison shop to purchase an Advantage plan. Advantage plan availability varies by locale. The Advantage plan website () allows you to customize features and cost. (You may find some added features are worth the extra cost.)

Since TFL is your Medicare supplement, you do not need to shop for Medicare supplement insurance.

Beware: Many Advantage plans provide automatic drug coverage, also known as Part D. As TFL members, you probably won't want another drug plan. Because TRICARE always pays last, you may find yourself filing manual claims to Express Scripts to exercise your TRICARE drug coverage. Plus, you will lose TRICARE home delivery by having another drug plan.
