

## **President's Message**

Do you know someone with ALS, Lou Gehrig's disease? I do. The downward spiral of this friend of mine is a terrible thing to think about, let alone watch, as his wife has to do. As a cadet at the Air Force Academy, this friend was even a roommate for a semester during our upper class years. He was an amazing young man who became an accomplished officer and fighter pilot. Yet, now he is afflicted with a disease that keeps him from enjoying his family and retirement. ALS usually ends life from two to five years after contracting the disease. My friend has been living with this debilitation since 2018. His wife deserves an award for the care and comfort she has provided for her husband. Yet, unless he lives with the disease for eight years, she is not compensated at all for this service-connected death. There is legislation currently going through Congress to change the time frame to match the expected lifetime of the veteran. This bill was reintroduced by Senators Coon (DE) and Murkowski (AK), who were also the lead sponsors of and instrumental in President Biden signing the

## Here's What the NDAA Means for Your Tricare Coverage (Link)

Each year, MOAA advocates to close TRICARE coverage gaps to ensure the military health care benefit evolves with changes in technology, treatment protocols, and standards set by high quality commercial plans.

A provision in the recently signed FY 2022 National Defense Authorization Act (NDAA) adds preconception and prenatal carrier screening coverage as a benefit under the TRICARE program for certain genetic conditions including cystic fibrosis, spinal muscular atrophy, fragile X syndrome, Tay-Sachs disease, hemoglobinopathies, and conditions linked with Ashkenazi Jewish descent. This provision brings TRICARE in line with the American College of Obstetricians and Gynecologists Committee Opinion on carrier screening for genetic conditions.

After TRICARE stopped covering lab developed tests (including many diagnostic genetic tests) in 2013, MOAA's advocacy led to the introduction of the TRICARE Laboratory Developed Test (LDT) demonstration project (link) in 2014. The demonstration provides beneficiary access to LDTs that have been reviewed for safety and effectiveness. The FY 2022 NDAA builds on the project's progress by ensuring beneficiaries have coverage should they elect carrier screening to assess reproductive risk associated with certain genetic conditions.

#### **Chiropractic Care Progress**

TRICARE coverage for chiropractic care is another MOAA priority. Our advocacy has focused on the importance of supporting non-pharmaceutical treatments for chronic pain, closing coverage gaps with Medicare and commercial plans, and accepting the Joint Commission's addition of chiropractic as a standard of care for pain management.

The House Armed Services Committee report for its mark of the FY 2022 NDAA strongly encourages DoD to expand the TRICARE benefit to include chiropractic care for servicemembers and beneficiaries.

This is not a legislative requirement, so MOAA will build on this momentum by continuing our advocacy on chiropractic coverage, particularly important since the opioid crisis has underscored the risks associated with relying on pharmaceutical treatments for chronic pain.

### **TRICARE Young Adult**

For the remainder of the 117th Congress, MOAA will continue to build support for the Health Care Fairness for Military Families Act, which would extend coverage to young adult dependents and bring TRICARE in line with commercial plan requirements. We regularly hear from families who are disappointed to learn military kids' coverage is lacking compared to their civilian peers who are covered by their parents' health plans until age 26.

While the TRICARE Young Adult fix was not included in the FY 2022 NDAA, House leads Reps. Elaine Luria (D-Va.) and Michael Waltz (R-Fla.) urged support for the legislation during the Armed Services full committee markup. On the Senate side, Sen. Mark Kelly (D-Ariz.) introduced an amendment addressing TYA, but it was not considered when the Senate chose to accept the House-negotiated version as time constraints loomed.

Cost is the main barrier to TRICARE Young Adult parity – MOAA will continue to build support among member offices to overcome this obstacle while ensuring the young adult eligibility expansion is not funded by raising TRICARE fees.

## Here's How You Can Support Veterans With ALS (Link)

It's not up for debate: ALS is a veterans' disease, and one we need to take seriously. Veterans are up to 10 times more likely to develop amyotrophic lateral sclerosis (ALS) compared to the civilian population, according to AMSUS, The Society of Federal Health Professionals, in an October 2019 report.

This fast-moving disease is currently 100% fatal, progressively degenerative, and comes with an average lifespan of two to five years from diagnosis. As a result, ALS has a huge impact on veterans and their family members, who quickly become caregivers as the disease progresses.

And while legislation recently passed to provide more funds into research and treatment of ALS, the unique needs of these family caregivers are not getting enough attention. Like any military spouse, the spouses of veterans with ALS have sacrificed much for our country. When they become caregivers because of the onset of ALS, they sacrifice even more.



That's why it surprised me to learn that while we provide compensation to spouses of veterans who die from a disabling, service-connected condition, the spouses of veterans who die from ALS are usually not eligible for the entire compensation. The reason? The current policy allowing a \$305 monthly increase in Dependency and Indemnity Compensation (DIC) for surviving spouses is only available when the veteran lives for eight or more years with their disabling disease.

Is it the fault of these ALS caregiver spouses that ALS moves so quickly and most people diagnosed with the disease are gone in five years or less? This is our issue, and one we need to confront head on.

I recently had the opportunity to speak with MOAA members who are facing the daily challenges of this dreaded disease. They are losing neurological and muscular functions, and over time losing the ability to breathe or talk. Interestingly, ALS does not affect mental functions, but it progressively robs people of their abilities to walk, use their hands and arms, speak, and ultimately breathe. The individuals want to stay in the fight, they want to find solutions, and they certainly are passionate about research and breakthrough therapies.

But these veterans also care deeply about their spouses, who often must leave their jobs to care for them as their ALS progresses. Caring for a person with ALS is not for the faint of heart; over time, it encompasses everything about the person's daily life, from eating to communicating to bathing to breathing. These veterans deserve to know that their service-connected illness – ALS – will be treated with the serious illness it deserves, and that their spouses will not be penalized simply because of the unique nature of the disease.

We can honor the service and sacrifice of these surviving spouses by securing the increased rate of DIC regardless of how long the veteran had the disease prior to death.

A bill now in Congress, the Justice for ALS Veterans Act (H.R. 5607 | S. 3483), would do just that. The bipartisan legislation would rectify this glaring imbalance by ensuring we have the backs of the surviving spouses of veterans who die from ALS. It would make all surviving spouses whose servicemember died as a result of ALS eligible for the DIC increase of \$305 regardless of how long they lived with the condition.

## What's New With Required Minimum Distributions for 2022 (Link)

Most holders of Individual Retirement Accounts (IRAs), including employer-provided defined contribution plans, are familiar with the COVID-influenced changes (SECURE Act) to mandatory age-based distributions.

If you did not reach age 70½ until after Dec. 31, 2019, then mandatory distributions were delayed until no later than April 1 of the year after the owner's 72nd birth year. Future distributions must occur by Dec. 31 of each year. If you reached age 72 in 2021 but plan to delay your Required Minimum Distribution (RMD) until just prior to April 2022, you will be required to make another withdrawal prior to Dec. 31, 2022.

If the account owner reached 70½ prior to Dec. 31, 2019, then the initial RMD must have commenced prior to April 1, 2020.

Life expectancy tables recently have been updated, reducing the amount of previously calculated RMDs for 2022 and beyond. IRS Publication 590-B is the guiding document for IRAs. As of Jan. 26, 2022, the 590-B is still in draft form. However, the RMD worksheets (Appendix A) and Life Expectancy Tables (Appendix B) are available to make RMD estimates.

Simplified Employee Pension (SEP) plans, SIMPLE IRA Plans, and Qualified Plans -- defined contribution plans, like the Thrift Savings Plan (TSP) and 401(k)s -- adhere to IRS Publication 560, which is also still in draft form for 2021 returns. Your defined contribution administrator should calculate RMDs for their account holders.

A comparison of IRA versus Defined Contribution plan RMDs can be found at this <u>link</u>.

Making Qualified Charitable Distributions (QCDs) from your IRA? QCDs may be reduced or require an additional adjustment after the 2019 tax season. See page 13 of Pub 590 and the QCD deduction adjustment worksheet (Appendix D).

#### SURVIVING SPOUSES CORNER

SBP-DIC Offset: Surviving Spouse Benefit Payments Will Change in February (Link)

Surviving spouses whose benefits increased last year as part of the phased elimination of the Survivor Benefit Plan-Dependency/Indemnity Compensation (SBP-DIC) offset will see another increase on Feb. 1.

MOAA waged a long fight to end this offset, commonly referred to as the "widows tax," under which the amount of a surviving spouse's SBP annuity would be reduced, dollar for dollar, by the amount of their DIC payment.

Language in the FY 2020 National Defense Authorization Act (NDAA) will end the offset by 2023. Here's the breakdown:

In 2021, all surviving spouses affected by the change should have seen their SBP offset cut to no more than two-thirds of their DIC payment.

This year, beginning with their Feb. 1 payment, surviving spouses should see their SBP offset cut to no more than one-third of their DIC payment.

In 2023, the offset will be removed entirely.

All surviving spouses eligible for the Special Survivors Indemnity Allowance (SSIA) will continue to receive that benefit in 2022, according to the Defense Finance and Accounting Service (DFAS). The maximum SSIA benefit is \$346 per month for 2022, per DFAS, or equal to the gross SBP amount (if SBP is less than \$346 a month).

SSIA will no longer be paid in 2023, when the full offset is removed.

Surviving spouses affected by this change should have received a letter from DFAS in December with individualized estimates of your upcoming benefit payments. - Urge Elected Officials to Support Comprehensive Toxic Exposure Reform Legislation (Link), Comprehensive toxic exposure reform is needed to ensure we avoid the problems faced by Vietnam veterans who were exposed to Agent Orange.
- Ask Congress to Preserve Arlington National Cemetery Eligibility for 20-Year Retirees (Link), Help MOAA stay in the middle of this important conversation – Contact you elected officials and urge them to designate in the FY 2023 NDAA the next national cemetery as ANC reaches capacity.
- Another Continuing Resolution is in the Works (Link), MOAA remains concerned Congress will remain focused on party priorities and the upcoming midterm elections, resisting their responsibility to come together to fully fund our government.
- Ask Your Lawmakers to Support the Jobs and Childcare for Military Families Act (Link), The military spouse unemployment rate is not a new concern, but like many ongoing problems, it's been made worse by the economic fallout from the COVID-19 pandemic.
- Urge Your Elected Officials to Fix the TRICARE Young Adult Coverage Gap (Link), MOAA continues efforts to build support for The Health Care Fairness for Military Families Act of 2021. These bipartisan and bicameral pieces of legislation would expand TRICARE eligibility to young adult dependents up to age 26, bringing TRICARE in line with commercial plan requirements.
- Ask Your Lawmakers to Support the Military Hunger Prevention Act (Link), Food insecurity among junior servicemembers is not a new concern, but like many ongoing problems, it's been made worse by the economic fallout from the COVID-19 pandemic. The Military Hunger Prevention Act would establish a Basic Needs Allowance (BNA) for these servicemembers, helping them overcome financial difficulties and allowing them to concentrate on their duties.
- Ask Your Lawmakers to Support the Retained Skilled Veterans Act (Link), This bipartisan legislation would end so-called "180-day rule," which imposes a waiting period on those leaving the service before they can take on certain types of DoD civilian employment. Many jobs are empty as qualified applicants with security clearances are forced to look elsewhere to start their careers.
- Ask Your Legislators: Adjust SGLI/VGLI for Inflation Supporting Families of Fallen Act (Link), Servicemembers' Group Life Insurance (SGLI) and Veterans' Group Life Insurance (VGLI) coverage amounts have not been updated since 2005. This law would raise the level from \$400,000 to \$500,000 – a necessary move to preserve the valued of this program in the face of inflation.
- Ask Your Lawmakers to Support the Military Retiree Survivor Comfort Act (Link), Financial concerns and stress can be a terrible burden on top of an already stressful situation for a newly widowed spouse. The Military Retiree Survivor Comfort Act (H.R. 2214 and S.1669) will allow survivors to gradually repay the amount over the next 12 months and have an opportunity to request for debt forgiveness through DoD.
- Urge Your Senators to Support Legislation to Repeal the TRICARE Select Enrollment Fee (Link) Act now to urge your senators to support the TRICARE Select Restoration Act, which is an important first step to repeal the enrollment fee for grandfathered retirees.
- Urge Officials-Support Legislation Extending TRICARE Coverage to Certain 'Gray Area' Retirees (Link) The TRICARE Fairness for National Guard and Reserve Retirees Act would ensure these "gray area" retirees who qualify for retirement pay before age 60 are eligible for the TRICARE retiree benefit. Under current law, gray area retirees who want TRICARE coverage must purchas TRICARE Retired Reserve (TRR), an expensive premium-based plan, even if they are receiving Continued next page 9 retired pay.

- Support Health Care for Children of Disabled Veterans or Veterans Who Have Died Due to a Service-Connected Disability (Link) The CHAMPVA Children's Care Protection Act would expand coverage under the VA program for children of eligible veterans so they can have health care until age 26, as afforded to most Americans through private and federal policies.
- Urge Your Legislators to Support Concurrent Receipt (Link) Contact your representative and senators and urge them to support The Major Richard Star Act, which would provide concurrent receipt for servicemembers unable to complete 20 years of service due to combat-related injuries. Help ensure these men and women get their full service-earned retirement, as well as their disability compensation from the VA.
- Help MOAA Secure Health Care for Servicemembers in the Selected Reserve (<u>Link</u>) The
  National Guard and Reserve play critical roles in our national defense and emergency response
  missions. The Healthcare For Our Troops Act would provide medical and dental care for Selected
  Reserve members at no out-of-pocket cost, bringing their coverage in line with their active duty
  counterparts.
- Act Now to Improve Survivors' Benefits (Link) Bipartisan legislation in the House and Senate (H.R. 3402/S.976) would align Dependency and Indemnity Compensation payments with outer federal survivor benefits. Ask your legislators to show their support and make a long-overdue correction to this injustice.
- Toxic Exposure Stories (Link) The fight for comprehensive toxic exposure reform is ramping up as we start the second session of the 117th Congress. To help in these efforts, please share your stories for possible use in MOAA articles, testimony, or meetings with lawmakers.
- **Justice for ALS Veterans** (<u>Link</u>) Survivors should not be disadvantage when an aggressive illness like ALS takes their loved one far too soon. The unique nature of this disease means few veterans survive long enough to receive the enhanced benefits that other totally disabled veterans receive.

The passed legislation includes a 3% pay raise for service members, some restraint on TriCare costs, hazardous duty incentive pay parity for Guard and Reserve members, some Toxic Exposure coverage, along with funding for some military housing.
